[OAR 581-022-2220](#)

Isolation spaces are required. Per OAR 581-022-2220, schools must maintain supervised space to isolate the sick that is separate from the space where other health care tasks take place and cannot be shared spaces or occupied working offices. In SLSD, protocols are established in each building for a health room and an isolation room (for ill or exposed) to separate people who have or may have a contagious disease from people who are not sick required by OAR 581-022-2220. Each school location has established protocols to include an isolation room for ill staff or students or for suspected illness.
